Fine Arts and Crafts Festival

June 1 and 2, 2019 LaGrange, KY

Be a part of our 20th Arts on the Green, Fine Arts and Crafts Festival, which benefits the Arts Association of Oldham County (AAOC), LaGrange, KY. Show hours are 10-5 Saturday & 10-4 Sunday. Arts on the Green (AOG) is held on the Oldham County Courthouse Square, 100 W. Main Street, LaGrange, KY 40031. Conveniently located just 22 miles N.E. of Louisville, KY.

This is a juried event and only artists displaying their own original work are eligible. Exhibitors must be present throughout both days of the show. The emphasis of the show is on original, fine arts & crafts. 2-D artists working with prints must label all prints as such and numbered edition prints only are acceptable. Prints can comprise up to 50% of the total display. No commercially made products, ceramics made from molds, kit objects, glass from patterns or mass produced items may be exhibited. All work must be labeled with a price, or "not for sale." The committee reserves the right to reject any work, display or exhibitor which in its opinion does not conform to the artist's work as represented by the submitted application.

TO JURY: Even returning artists must jury in the show. Send 3 labeled photos or CD which accurately represent the work to be exhibited for each category and a 4th photo of Booth Display. Booth display is important; recommendations are available for first time exhibitors of a show. Artists applying online may email application, scan required photos and submit credit card information.

You may exhibit in more than one medium. You must jury in, pay the jury fee, and be accepted in each category. All art work exhibited must be reflective of the art juried in the show.

Artists and Craftsmen will be juried solely on the photos submitted. *Do not send original work.* Photos and CD of accepted artists will be retained until the show and will be returned at check-in. Exhibitors are encouraged to submit a short explanation of their work including any special, unusual techniques and/or aspects of their work as well as a biography. This information may be used in publicity of the event.

BOOTH INFO: Outdoors! You must provide your own display and tent covering. Booth weights and/or stakes are required to protect your booth and fellow artist, whether on lawn or on the street. Be prepared for the weather. Artists must have their own insurance coverage. Booth space is 10' x 10' - 10' x 12'.

CHECK IN AND SET UP TIMES: Friday, May 31, 2019 10 am- 7 pm or Sat, June 1, 2019 before 9 am. Notification of set up times, and booth location TBA. Second street booths setup is after 1 pm. PHOTO I.D is required during Check-In. Also required is your vehicle license number.

BREAKDOWN TIME: Sunday, June 2, 2019 is NO EARLIER THAN 4 pm. The festival dates and times are advertised in ads, radio, television and other promotions with the festival dates and times. Early breakdown due to emergency, may be approved by Director on case by case basis. Artists leaving early without approval may not be invited back. Stay in touch with AOG office for inclement weather conditions and festival closure. This is a pet free event for exhibitors and customers.

HOSPITALITY: Complimentary breakfast: Saturday 7 am-10 am. Sunday 8 am-10 am. Booth sitters are available. Golf carts are as available.

RETURN ENVELOPE: Your application must be accompanied by a sufficient-sized, self addressed envelope with adequate postage for the return of photos/CD if not accepted. The show will not be responsible for postage or for loss or damage of photos.

The Best of Show 2019 winner is invited as the Featured Artist of AOG 2020. As such, the winning art piece is used for all marketing as appropriate.

Ribbons are awarded through 3rd place in all categories. Each artist is eligible for only one award per category. Judging begins at 10 am, Saturday, June 1, 2019. Winners are notified in the afternoon. Award checks will be issued at the close of the show.

FEES: Jury Fee \$25.00 per category Booth Fee \$200.00 Electricity Fee \$20.00 (limited spaces available)

Make all checks payable to AAOC. If using credit card, include information requested. AAOC members receive a \$10 discount off booth fee. Please verify your membership status prior to mailing application and renew prior to sending if needed. An Early Bird Discount of \$10 off booth space applies if your application is received by Dec. 31, 2018. Early Bird Discount is for members and non-members.

Prefer artists to apply through Zapplication. Zapplication does not charge artists to set up an account. Mailed application is acceptable.

Jury fees will be deposited upon receipt. Jury fees are non-refundable. Booth fees will be deposited when accepted in the show.

A separate check or charge is required for jury fee(s). Electric fee may be included in booth fee check.

Artists may share a booth and send one check for the booth fee. Each artist must jury in the show. Artists may have double booths.

An acceptance is a commitment to the show and no refund will be made for cancellation or rain-out. Exhibitors unable to attend must notify the director. Refund is reviewed on a case by case basis. No refunds will be issued 1 month prior to show.

DEADLINE: Application must be postmarked by March 31, 2019. Late entries will be considered for the show as space and time allows. Notification of acceptance is no later than April 15, 2019. More information about Check-In times and procedures will be emailed mid-May.
